Alabama Power Company (Alabama Power) is the Federal Energy Regulatory Commission (FERC or Commission) licensee for the R.L. Harris Hydroelectric Project (Harris Project) (FERC No. 2628-066). Alabama Power filed the Final License Application (FLA) for the Harris Project on November 23, 2021. Pursuant to 18 Code of Federal Regulations (C.F.R.) 4.32 (a)(6), Alabama Power published notices of the filing twice in daily newspapers in each county in which the Harris Project is located.

On December 17, 2021, Alabama Power filed affidavits serving as evidence of publication of the legal notice of filing of the FLA from *The Anniston Star*, *The Clay Times Journal*, and *The Randolph Leader*¹. 



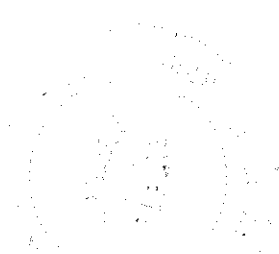
